RE: NATIONAL GREEN PHASE ADVISORY DECLARATION – O NEGATIVE RED BLOOD CELL INVENTORY

## Dear Colleagues:

This is a notice of a *Green Phase Advisory* impacting Group O Negative Red Blood Cells (RBC) declared by the National Emergency Blood Management Committee (NEBMC) on July 7, 2021. Decreased donor attendance combined with an increase in national Group O Negative RBC demand in response to eased COVID-19 restrictions have led to a supply concern expected to last up to 4 weeks. Please see the appended NEBMC Shortage Advisory for details.

Adherence with strategies to ensure optimal utilization of RBC is essential to ensure the availability of supply for patients requiring transfusion in urgent or emergent situations. We request your cooperation with implementation of the following strategies to help protect our inventory:

## Red Blood Cells:

- The decision to transfuse RBC should be in accordance with a restrictive strategy.
- Requests for RBC transfusion to anemic hospitalized inpatients (without ongoing bleeding) will be restricted to 1 unit at a time.
- In the setting of new patients with hemorrhage, blood group specimens <u>must</u> be drawn on arrival to allow for provision of group specific RBC as soon as possible.
  - o Uncrossmatched Group O Negative RBC will be issued for transfusion to women under 50 years of age;
  - Uncrossmatched Group O Positive RBC will be issued to men and women 50 and older, in accordance with best practice recommendations (*Exception: sites stocking only Group O negative RBC*);
- If a patient is likely to require significant (greater than 4 units) of Group O Negative RBC, please notify your local blood bank of the situation as soon as possible, to ensure appropriate preparedness and component availability.

**Blood donation** is encouraged to help Canadian Blood Services replenish their supply.
